On October 21, 2020, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's license to practice respiratory care. Respondent was required to complete five (5) hours of education in use and management of ventilators including CPAP and BIPAP pursuant to the terms of the Order.
