On November 29, 2020, the Wisconsin Real Estate Examining Board issued a Final Decision and Order ("Order") suspending Respondent's real estate broker license for not less than 30 days, effective 10 days from the date of the Order and until Respondent has successfully completed courses in business ethics and financial and office management, pursuant to the terms of the Order.
