ORDER


Pursuant to Wis. Stat. § 440.22, the costs of this proceeding in the amount of \$3,113.05 are assessed against Respondent and shall be payable by Respondent to the Department of Safety and Professional Services (Department) should Respondent ever apply for any credential with the Department in the future. Under Wis. Stat. § 440.22(3), the Department may not restore, renew or otherwise issue any credential to Respondent until Respondent has made payment to the Department in the full amount assessed.
