On December 10, 2020, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) limiting Respondent’s registered nurse license with certain terms and conditions. Pursuant to the Order, Respondent’s license may be suspended, without hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Respondent is in violation of the terms of the Order. As a result, the following is entered:

ORDER

1. Respondent’s registered nurse license (license no. 154531-30) is hereby SUSPENDED until further notice.
2. Respondent may petition the Board or its designee for termination of the suspension upon a demonstration of continued, successful compliance with the terms and conditions of the Order for at least the most recent thirty (30) days.
3. This order is effective the date of its signing.
