On December 10, 2020, the Wisconsin Board of Nursing issued a Final Decision and Order ("Order") limiting Respondent's registered nurse license with certain terms and conditions. - 2. Respondent may petition the Board or its designee for termination of the suspension upon a demonstration of continued, successful compliance with the terms and conditions of the Order for at least the most recent sixty (60) days.
