On January 14, 2021, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) requiring Respondent to complete three (3) hours of education in “critical thinking” within 90 days. On October 27, 2021, Respondent’s registered nurse license was suspended for failure to complete the education as ordered.

Based upon the information of record, which includes proof that Respondent has now completed the education, the following is entered:

ORDER

1. Respondent’s registered nurse license (license number 114299-30) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credential are removed.
3. This order is effective the date of its signing.
