On January 14, 2021, the Wisconsin Board of Nursing issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license with certain terms and conditions. Pursuant to the Order, Respondent's license may be suspended, without hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Respondent was found to be in violation of the terms of the impairment program contract dated January 22, 2020, and is therefore is in violation of the terms of the Order. As a result, the following is entered:

## <u>ORDER</u>

- 1. Respondent's professional nursing (#146695-30) is hereby SUSPENDED until further notice. Respondent may petition to have the suspension terminated after 30 days of continuous successful compliance.
  - 2. This order is effective the date of its signing.
