The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. Respondent Angela L. Minter, R.N., (DOB xx/xx/1961) is licensed in the state of Wisconsin as a registered nurse, having license number 108080-30, first issued on September 5, 1991, and current through February 28, 2022. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is located in Janesville, Wisconsin.

2. At all times relevant to this proceeding, Respondent was employed as a registered nurse at a health and rehabilitation center, located in Evansville, Wisconsin (Center).

3. On February 18, 2019, it was reported to the Center that Respondent was accepting money from Patient A for Respondent's daughter's college education.

4. Respondent was removed from Patient A's care and was suspended, pending investigation.

5. During the investigation, Patient A stated that she gave Respondent approximately \$400.00, on approximately five (5) separate occasions, for Respondent's daughter's college education. Patient A did not think it was an issue because it was not for Respondent.

6. Patient A stated that Respondent informed her not to disclose that she gave money to her daughter. Patient A also stated that Respondent was like a second daughter to her.

7. On February 20, 2019, Respondent admitted to accepting checks from Patient A for her daughter's Go Fund Me page for college. Respondent did not feel as though this was a problem because it was going right to her daughter's Go Fund Me page, to which anyone can donate.

8. Respondent was terminated from her employment with the Center.

9. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing has jurisdiction to act in this matter pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. \S 227.44(5).

2. By the conduct described in the Findings of Fact, Respondent violated Wis. Admin. Code \S N 7.03(4)(a), by soliciting, borrowing, misappropriating, obtaining, or attempting to obtain money or property from a patient or a patient's family.

3. By the conduct described in the Findings of Fact, Respondent violated Wis. Admin. Code \S N 7.03(4)(e)1.a., by failing to establish, maintain, or communicate professional boundaries with the patient.

4. By the conduct described in the Findings of Fact, Respondent violated Wis. Admin. Code N 7.03(4)(e)1.b., by engaging in relationships with patients that could impair the nurse's professional judgment.

5. As a result of the above conduct, Respondent is subject to discipline pursuant to Wis. Stat. 441.07(1g)(b) and (d).

ORDER

1. The attached Stipulation is accepted.

2

2. Respondent is REPRIMANDED.

3. The registered nurse license issued to Respondent (license number 108080-30) is LIMITED as follows:

- a. Within ninety (90) days of the date of this Order, Respondent shall at her own expense, successfully complete three (3) hours of education on the topic of professional boundaries in nursing offered by a provider preapproved by the Board's monitoring liaison, including taking and passing any exam offered for the courses.
- b. Respondent shall submit proof of successful completion of the education in the form of verification from the institution providing the education to the Department Monitor at the address stated below. None of the education completed pursuant to this requirement may be used to satisfy any continuing education requirements that have been or may be instituted by the Board or Department, and also may not be used in future attempts to upgrade a credential in Wisconsin.
- c. The Board's monitoring liaison may change the number of credit hours and/or education topics in response to a request from Respondent. The monitoring liaison may consider the topic availability and/or hours of education when determining if a change to the ordered education should occur.
- d. This limitation shall be removed from Respondent's license after satisfying the Board or its designee that Respondent has successfully completed all of the ordered education.

4. Pursuant to the Enhanced Nurse Licensure Compact (Compact), Respondent may not practice in another Compact State, other than Wisconsin, while their license is encumbered by any term or restriction of this Order.

5. Within 120 days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$769.00.

6. Request for approval of courses, proof of successful course completion and payment of costs (made payable to the Wisconsin Department of Safety and Professional Services) shall be sent by Respondent to the Department Monitor at the address below:

In the event Respondent violates any term of this Order, Respondent's license (108080-30), or Respondent's right to renew her license, may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of the Order. The Board may, in addition and/or in the alternative refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.

8. This Order is effective on the date of its signing.

Respondent Angela L. Minter, R.N., and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.

2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:

- the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Respondent;
- the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
- the right to testify on Respondent's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.

4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Board of Nursing (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division
