You are hereby notified that you are subject to a forfeiture of **\$1,000.00** in accordance with Wis. Admin. Code § SPS 305.125 for engaging in plumbing without possessing a proper plumbing credential. This forfeiture must be paid within 30 days of the date of mailing of this Notice, or a 12% interest penalty will be assessed and/or enforcement action may be taken against you.

The forfeiture of **\$1,000.00** shall be made out to the "Department of Safety and Professional Services." Include in the memo line "19 UNL 110" and send to the following address:

You have the right to request a review of the assessment of forfeiture by sending a request addressed to Division Administrator, Division of Industry Services, P.O. Box 7302, Madison, WI 53707-7302. Any review of the assessment of forfeiture will be held in accordance with the requirements set forth in Wis. Admin. Code § SPS 305.125. Such request for review shall set out specifically and in full detail every reason why this order is unreasonable, and every issue to be considered by the Department in the review.

You are receiving this forfeiture because a department investigation found that you engaged in plumbing without a license. Specifically, the investigation found a preponderance of evidence that you performed plumbing at 2308 Carlisle Avenue, Racine, Wisconsin. You were hired to

remodel a basement. Allegedly, you did a complete re-pipe and work on the building drain and another contractor, Success Plumbing, had to redo all the work done to bring it up to code. Further, you performed plumbing at 1501 Buchanan Street, Racine, Wisconsin. You did re-piping work and another contractor had to be hired to fix the issues. Wisconsin code states that the Department may issue a forfeiture against an unlicensed individual if it is found that the individual installs plumbing when a master plumber is not in charge of the plumbing installation. Wisconsin code allows the Department to issue a separate forfeiture for each offense. The Department is utilizing prosecutorial discretion in reducing the forfeiture to a one (1) time offense. Should this matter go to a hearing the Department will pursue full forfeitures as allowed by Code.

For these reasons a forfeiture of \$1,000.00 is assessed in accordance with Wis. Admin. Code § SPS 305.125.
