You are hereby notified that you are subject to a forfeiture of \$250.00 in accordance with Wis. Stat. § 101.88 because you engaged in electrical work without possessing the necessary credentials as required by Wisconsin Code. This forfeiture must be paid within 30 days of the date of mailing of this Notice, or a 12% interest penalty will be assessed and/or enforcement action may be taken against you.

The forfeiture of \$250.00 shall be made out to the "Department of Safety and Professional Services." Include in the memo line "18 COM 232" and send to the following address:

You are receiving this forfeiture because you performed electrical work at 4606 Augustine Avenue, Weston, WI without possessing the proper electrical licensing credentials. An investigation was opened and it was determined that you performed electrical work at the site. Wis. Admin. Code Sec. SPS 305.40 and Wis. Stat. Sec. 101.862 requires that only licensed individuals can perform electrical work in the State of Wisconsin. An investigation by the Department found that both the homeowner and the inspector stated that you engaged in electrical work. Further, conversations with the individual listed on the permit to perform the

electrical work found that he claimed he did not perform the work. There is a preponderance of evidence that you engaged in unlicensed electrical work. Wis. Stat. Sec. 101.88 states that the Department may issue a forfeiture of not less than \$25 nor more than \$500 to any person who violates a rule promulgated by the Department.

For these reasons the forfeiture of \$250.00 is assessed in accordance with Wis. Stat. § 101.88.
