On March 11, 2021, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice as a registered nurse for three (3) months. Respondent may petition for a stay of suspension upon thirty (30) consecutive days of compliance with the provisions of Sections C and D of the Order.
