The parties in this matter agree to the terms and conditions of the attached Stipulation as the resolution of this application. The Wisconsin Board of Nursing (Board) adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

## **FINDINGS OF FACT**

- 1. Caitlyn J. Ellison (Applicant) resides in Wisconsin.
- 2. On or about September 13, 2020, Applicant filed an application (no. 732856) for a Wisconsin Registered Nurse credential.
  - 3. Applicant has the following violations and convictions:
    - A. On or about October 21, 2017 Operating while Intoxicated (OWI) 1<sup>st</sup>, an ordinance violation.
    - B. On or about October 24, 2017 Prohibited Alcohol Concentration (PAC) 1<sup>st</sup>, an ordinance violation.
      - Applicant states went to a bar and had some drinks with a friend. Applicant believed she was safe to drive and started to drive herself home. Applicant swerved and was pulled over. Applicant failed the Standardized Field Sobriety Test (SFST) and blew a Preliminary Breath

- Test (PBT) of .146. Applicant states at the time she was using alcohol to cope with stress.
- Applicant paid a fine, her driver's license was revoked, completed her Alcohol and Other Drug Abuse (AODA) assessment, and completed the group dynamics course.
- C. On or about August 19, 2019 OWI 2<sup>nd</sup>, a misdemeanor conviction.
  - i. Applicant made a poor choice to drive home after imbibing with friends at a bar. She fell asleep behind the wheel and crashed her car into another car. Applicant states she was very stressed with her accelerated nursing program in conjunction with her personal life stresses. She failed the SFST and blew a PBT of .20.
  - ii. Applicant paid a fine, served thirty (30) days jail, her driver's license was revoked for twelve (12) months, she had an Ignition Interlock Device (IID) for twelve (12) months, and completed an AODA Assessment.
- D. On or about September 9, 2019 OWI 3<sup>rd</sup>, a misdemeanor conviction.
  - i. Applicant stated she had a difficult day and went out drinking with friends. After imbibing, Applicant made the poor decision to drive herself home. Applicant stated she does not remember leaving or driving. Applicant got into an accident, displayed numerous indicators of intoxication, failed the SFST, and had a Blood Alcohol Concentration (BAC) of .215.
  - ii. Applicant was placed on probation for eighteen (18) months, her driver's license is revoked for twenty-four (24) months, she has an IID for twenty-four (24) months, she completed an AODA assessment, served fifteen (15) days jail, and paid a fine. Applicant was accepted into OWI treatment court. After successful completion of OWI treatment court, Applicant was discharged from probation early.
- 4. Applicant's most recent AODA Assessment dated July 22, 2019, diagnosed Applicant with Alcohol Dependency.
- 5. On or about September 2, 2020, Applicant was discharged from outpatient treatment for completing all treatment recommendations and obtaining maximum benefit from treatment. Applicant discharged with a diagnosis of alcohol use disorder and unspecified anxiety disorder.
- 6. In resolution of this matter, Applicant consents to the entry of the following Conclusions of Law and Order.

#### **CONCLUSIONS OF LAW**

- 1. The Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 441.07 and is authorized to enter the attached Stipulation pursuant to Wis. Stat. §§ 15.08(5)(c) and 227.44(5).
- 2. Pursuant to Wis. Stat. § 441.07(1g)(b), the Board may deny an initial license or revoke, limit, suspend, or deny the renewal of a license of a registered nurse for one or more violations of this subchapter or any rule adopted by the Board under the authority of this subchapter.
- 3. Pursuant to Wis. Stat. § 441.07(1g)(c), the Board may deny an initial license or revoke, limit, suspend, or deny the renewal of a license due to acts which show the registered nurse, nurse-midwife or licensed practical nurse to be unfit or incompetent by reason of negligence, abuse of alcohol or other drugs or mental incompetency
- 4. Pursuant to Wis. Stat. § 441.07(1g)(d), the Board may deny an initial license or revoke, limit, suspend, or deny the renewal of a license of a registered nurse for misconduct or unprofessional conduct.
- 5. The Board may deny an application for licensure if Applicant is unable to practice safely by reason of alcohol or other substance use pursuant to Wis. Admin. Code § N 7.03(6)(f).
- 6. Applicant's three (3) OWI convictions and AODA diagnosis of alcohol dependency demonstrate Applicant to be unfit or incompetent or unable to practice safely by reason of alcohol abuse.
- 7. As a result of the above conduct, Applicant is subject to limitations on her license pursuant to Wis. Stat. §§ 441.07(1g)(b),(c), and (d), and Wis. Admin. Code § N 7.03(6)(f).

#### ORDER

- 1. The attached Stipulation is accepted.
- 2. Limitations upon Applicant's Registered Nurse credential are necessary to ensure that she is fit and competent to practice as a Registered Nurse.
- 3. Applicant's ability to practice as a Registered Nurse in the state of Wisconsin, and her privilege to practice pursuant to the Enhanced Nurse Licensure Compact (Compact), is LIMITED as follows:
  - A. For a period of at least two (2) years from the date of this Order:
    - i. Applicant shall enroll and participate in a drug and alcohol monitoring program which is approved by the Department (Approved Program).

Enrollment shall occur within thirty (30) calendar days from the date of this Order.

- ii. At the time Applicant enrolls in the Approved Program, Applicant shall review the rules and procedures made available by the Approved Program. Failure to comply with all requirements for participation in drug and alcohol monitoring established by the Approved Program is a substantial violation of this Order. The requirements shall include:
  - 1. Contact with the Approved Program as directed on a daily basis, including vacations, weekends and holidays.
  - 2. Production of a urine, blood, sweat, fingernail, hair, saliva or other specimen at a collection site designated by the Approved Program within five (5) hours of notification of a test.
  - 3. The Approved Program shall require the testing of specimens at a frequency of not less than twenty-eight (28) times per year, (one of which may be a hair test at the Board's discretion) for at least the first year of this Order. Thereafter, the Board may adjust the frequency of testing on its own initiative at any time.
- iii. Applicant shall abstain from all personal use of alcohol.
- iv. Applicant shall abstain from all personal use of controlled substances as defined in Wis. Stat. § 961.01(4), except when prescribed, dispensed or administered by a practitioner for a legitimate medical condition. Applicant shall disclose Applicant's drug and alcohol history and the existence and nature of this Order to the practitioner prior to the practitioner ordering the controlled substance. Applicant shall at the time the controlled substance is ordered immediately sign a release in compliance with state and federal laws authorizing the practitioner to discuss Applicant's treatment with, and provide copies of treatment records to, the Board or its designee. Copies of these releases shall immediately be filed with the Department of Safety and Professional Services Monitor (Department Monitor).
- v. Applicant shall report to the Department Monitor all prescription medications and drugs taken by Applicant. Reports must be received within twenty-four (24) hours of ingestion or administration of the medication or drug, and shall identify the person or persons who prescribed, dispensed, administered or ordered said medications or drugs. Each time the prescription is filled or refilled, Applicant shall immediately arrange for the prescriber or pharmacy to fax and mail copies of all prescriptions to the Department Monitor.

- vi. Applicant shall provide the Department Monitor with a list of over-the-counter medications and drugs that he may take from time to time. Over-the-counter medications and drugs that mask the consumption of controlled substances or of alcohol, create false positive screening results, or interfere with Applicant's treatment and rehabilitation, shall not be taken unless ordered by a physician, in which case the drug must be reported as described in the paragraph 3.A.v.
- vii. All positive test results are presumed valid and may result in automatic suspension of licensure by the Board or the Board's designee. Applicant must prove by a preponderance of the evidence an error in collection, testing, fault in the chain of custody or other valid defense.
- viii. If any urine, blood, sweat, fingernail, hair, saliva or other specimen is positive or suspected positive for any controlled substances or alcohol, Applicant shall promptly submit to additional tests or examinations as the Board or its designee shall determine to be appropriate to clarify or confirm the positive or suspected positive test results.
- B. For a period of at least two (2) years from the date of this Order:
  - i. Within thirty (30) days of the date of this Order, Applicant shall provide proof to the Department Monitor that Applicant is enrolled in AODA counseling with an AODA counseling provider (Treater), whose credential is in good standing, and approved by the Board. Applicant shall participate in, cooperate with, and follow all treatment recommended by Treater.
  - ii. Applicant shall immediately provide Treater with a copy of this Order and all other subsequent orders.
  - iii. Applicant's treatment shall include individual and/or group therapy sessions at a frequency to be determined by Treater, but not less than once a month. Therapy may end only upon a determination by the Board or its designee after receiving a petition for modification, including a recommendation from Treater expressly approving termination of therapy.
  - iv. Treater shall immediately report any relapse, violation of any of the terms and conditions of this Order, and any suspected unprofessional conduct, to the Department Monitor. If Treater is unable or unwilling to serve as Treater, Applicant shall immediately seek approval of a successor Treater by the Board or its designee.
  - v. Treater shall submit formal written reports to the Department Monitor on a quarterly basis, as directed by the Department Monitor. These reports shall assess Applicant's progress in the mental health

treatment sessions, abstinence from all substances, and drug and alcohol testing. Treater shall report immediately to the Department Monitor any violation or suspected violation of this Order.

- ix. Applicant shall attend Narcotics Anonymous and/or Alcoholics Anonymous meetings or a Board-approved equivalent program for recovering professional, no less than twice per week. Attendance of Applicant at such meetings shall be verified and reported quarterly to the Department Monitor.
- C. For a period of at least two (2) years from the date of this Order:
  - x. Applicant shall provide Applicant's nursing employer with a copy of this Order before engaging in, or continuing to engage in, any nursing employment. Applicant shall provide the Department Monitor with written acknowledgment from each nursing employer that a copy of this Order has been received. Such acknowledgment shall be provided to the Department Monitor within fourteen (14) days of beginning new employment and/or within fourteen (14) days of the date of this Order for employment current as of the date of this Order.
  - xi. It is Applicant's responsibility to arrange for written reports from her direct supervisor to be provided to the Department Monitor on a quarterly basis. These reports shall assess Applicant's work performance, attendance and include the number of hours of active nursing practice worked during that quarter.
  - xii. Applicant <u>may</u> work as a nurse or other health care provider in a setting in which Applicant has access to controlled substances.
  - xiii. Applicant shall report to the Board any change of employment status, residence, address or telephone number within five (5) days of the date of change. This report shall be provided in addition to formal change of address notification pursuant to Wis. Stat. § 440.11.
  - xiv. Applicant shall commit no new violations of law and shall report all law enforcement contacts leading to arrest, charge or conviction, including DWI/OWI and municipal/ordinance violations, to the Department Monitor within forty-eight (48) hours of any such event, including any convictions resulting from pending charges.
- 4. Applicant may petition the Board on an annual basis for modification of the terms of this Order, however no such petition for modification shall occur earlier than one (1) year from the date of this Order. Any petition for modification shall be accompanied by a written recommendation from Applicant's Treater expressly supporting the specific modifications sought. Denial of a petition in whole or in part shall not be considered a denial of a license within the

meaning of Wis. Stat. § 227.01(3)(a), and Applicant shall not have a right to any further hearings or proceedings on the denial.

- 5. After two (2) consecutive years of successful compliance, including at least six hundred (600) hours of approved nursing practice each year, the Applicant may petition the Board for return of full licensure. The Board may grant or deny any petition, in its discretion, or may modify this Order as it sees fit.
- 6. Pursuant to the Compact, Applicant may not practice in a Compact state, other than Wisconsin, while her license is encumbered by any limitation or restriction imposed by this order.
- 7. Any requests, petitions, reports and other information required by this Order shall be mailed, e-mailed, faxed or delivered to:

- 8. In the event Applicant violates any term of this Order, Applicant's license, or Applicant's right to renew his license, may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing. The Board or its designee may terminate the suspension if provided with sufficient information that Applicant is in compliance with the Order and that it is appropriate for the suspension to be terminated. Whether to terminate the suspension shall be wholly in the discretion of the Board or its designee. The Board may, in addition and/or in the alternative refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.
- 9. Applicant shall be responsible for all costs and expenses incurred in conjunction with the monitoring, screening, supervision, and any other expenses associated with compliance with the terms of this Order. Being dropped from a program for non-payment is a violation of this Order.
  - 10. This Order is effective on the date of its signing.

It is stipulated between Applicant and the Wisconsin Board of Nursing (Board) as follows:

- 1. Applicant filed an application for a Registered Nurse license.
- 2. Information received by the Board reflects a basis for denial of licensure.
- 3. Based upon the information of record, the Board agrees to issue, and Applicant agrees to accept, an Order granting a Registered Nurse license, subject to the terms and conditions set forth in the attached Order adopting the Stipulation.

- 5. Applicant is aware of Applicant's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.
- 6. Applicant agrees to the adoption of the attached Order Granting Limited License by the Board. The parties to the Stipulation consent to the entry of the attached Order Granting Limited License without further notice, appearance, or consent of the parties.
- 7. Applicant waives all rights to any appeal of the Board's Order, as adopted in the form as attached.
