On March 26, 2021, the Wisconsin Professional Engineer Section of the Wisconsin Examining Board of Architects, Landscape Architects, Professional Engineers, Designers, and Professional Land Surveyors ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional engineer certificate of registration. Respondent was required to complete two (2) hours of education in ethics pursuant to the terms of the Order.
