On April 8, 2021, the Wisconsin Board of Nursing (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s license to practice as a registered nurse and her certificate to practice as an advanced practice nurse prescriber. Respondent was required to complete six (6) hours of education in professional ethics pursuant to the terms of the Order.

Respondent has submitted proof that she successfully completed the required education and as a result the following is entered:
