On April 21, 2021, the Wisconsin Medical Examining Board (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s medicine and surgery license. Respondent was required to complete five (5) hours of education in opioid prescribing practices pursuant to the terms of the Order.
