On April 21, 2021, the Wisconsin Medical Examining Board (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s license to practice medicine and surgery. Respondent was required to complete three (3) hours of education in ethics and three (3) hours of education in safe prescribing of controlled substances pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:

ORDER

1. Respondent’s license to practice medicine and surgery (license number 39372-20) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credential are removed.
3. This order is effective the date of its signing.
