On April 21, 2021, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's license to practice medicine and surgery. Respondent was required to complete three (3) hours of education in ethics and three (3) hours of education in safe prescribing of controlled substances pursuant to the terms of the Order.
