On April 20, 2021, the Wisconsin Professional Counselor Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board ("Section") issued a Final Decision and Order ("Order") limiting Respondent's license to practice professional counseling. Respondent was required to complete three (3) hours of education in diagnosis and treatment planning, six (6) hours of education in trauma-informed care and evidence-based treatments for post-traumatic stress, and fourteen (14) hours of continuing education, with at least four (4) hours in ethics and boundaries pursuant to the terms of the Order.

Respondent has submitted proof that she successfully completed the required education and as a result the following is entered:
