The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Department of Safety and Professional Services (Department). The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

#### FINDINGS OF FACT

1. William B. Howell, C.S.A.C.-I.T., L.P.C.-I.T. (Respondent), (Year of Birth 1988), is certified in the state of Wisconsin to practice as a substance abuse counselor-in-training, having certificate number 19089-130, first issued on January 24, 2020, and current through February 28, 2023. Respondent's most recent address on file with the Department is located in Madison, Wisconsin 53703.

- 2. On December 27, 2019, Respondent applied for a substance abuse counselor-intraining (S.A.C.-I.T.) certificate and marked "no" in response to the question: "Have you ever been convicted of a misdemanor or a felony or do you have any felony or misdeanor charges pending against you?"
- 3. Respondent signed the application, which included an Affidavit of Applicant, and acknowledged that "I understand that failure to provide requested information, making any materially false statement and/or giving any materially false information in connection with my application for a credential or for renewal or reinstatement of a credential may result in credential application processing delays; denial, revocation, suspension, or limitation of my credential; or any combination thereof; or such other penalties as may be provided by law."
  - 4. Respondent's S.A.C.-I.T. certificate was granted on January 24, 2020.
- 5. Respondent was convicted of Operating While Intoxicated (OWI) (2<sup>nd</sup> w/ passenger <16 years old), a misdemeanor, on January 22, 2015. Respondent did not report this misdemeanor conviction on his application for a S.A.C.-I.T. certificate on December 27, 2019.
- 6. On March 17, 2020, Respondent applied for a professional counselor in-training (L.P.C.-I.T.) license and marked "yes" in response to the question "Have you ever been convicted of a misdemanor or a felony or do you have any felony or misdeanor charges pending against you? If yes, submit Convictions and Pending Charges." Respondent's 2015 OWI 2<sup>nd</sup> misdemeanor conviction was reviewed as part of his L.P.C.-I.T. application, and Respondent was granted an unrestricted L.P.C.-I.T. license on September 3, 2020.
- 7. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

## **CONCLUSIONS OF LAW**

- 1. The Wisconsin Department of Safety and Professional Services has jurisdiction to act in this matter pursuant to Wis. Stat. § 440.88, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondnet engaged in unprofessional conduct as defined by Wis. Admin. Code § SPS 164.01(2)(a), by submitting fraudulent, deceptive, or misleading information in conjunction with an application for a credential.
- 3. As a result of the above violations, Respondent is subject to discipline pursuant to Wis. Stat. § 440.88(6).

### <u>ORDER</u>

1. The attached Stipulation is accepted.

- 2. Respondent is REPRIMANDED.
- 3. Within ninety (90) days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$427.00.
- 4. Payment of costs (made payable to the Wisconsin Department of Safety and Professional Services) shall be sent by Respondent to the Department Monitor at the address below:

- 5. In the event that Respondent violates any term of this Order, Respondent's certificate (no. 19089-130) to practice as a substance abuse counselor-in-training in the state of Wisconsin may, in the discretion of the Department or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of the Order. The Department may, in addition and/or in the alternative, refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.
  - 6. This Order is effective on the date of its signing.

William B. Howell, C.S.A.C.-IT, L.P.C.-I.T (Respondent), and the Division of Legal Services and Compliance, Department of Safety and Professional Services, stipulate as follows:

- 1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.
- 2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:
  - the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
  - · the right to confront and cross-examine the witnesses against Respondent;
  - the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
  - the right to testify on Respondent's own behalf;
  - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
  - · the right to petition for rehearing; and
  - all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
- 3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.
- 4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Department of Safety and Professional Services (Department). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Department's Order, if adopted in the form as attached.
- 5. If the terms of this Stipulation are not acceptable to the Department, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the

Division of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Department, the parties agree not to contend that the Department has been prejudiced or biased in any manner by the consideration of this attempted resolution.

- 6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance may appear before the Department, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that the Department may have in connection with deliberations on the Stipulation.
- 7. Respondent is informed that should the Department adopt this Stipulation, the Department's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.
- 8. The Division of Legal Services and Compliance joins Respondent in recommending that the Department adopt this Stipulation and issue the attached Final Decision and Order.
