On May 4, 2021, the Wisconsin Real Estate Appraisers Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's certified residential appraiser certificate of licensure and certification. Respondent was required to complete twenty-six (26) hours of education consisting of the following courses: 1) National USPAP course, 2) Appraising Two to Four Unit Multi-Family Properties, and 3) Appraiser Self-Protection Documentation and Record Keeping pursuant to the terms of the Order.
