On May 5, 2021, the Wisconsin Dentistry Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's dental hygienist credential for an indefinite period. Respondent may petition for a stay of suspension upon the Respondent providing proof, which is determined by the Board or Designee to be sufficient, that Respondent has been in compliance with the provisions of Sections C and D of this Order, with the exception of submitting quarterly reports, which will not be due until ninety (90) days from the date of the Order. Respondent may submit a request any time after 45 days from the date of the Order.

Respondent's petition for an initial stay of suspension has been reviewed pursuant to the Order. Based upon the information of record, which demonstrates that Respondent qualifies for a stay of suspension at this time, the following is entered:

- 1. The suspension of Respondent's dental hygienist license (#4987-16) is hereby STAYED.
- 2. The stay is continuous, contingent upon Respondent's compliance with the terms and conditions of the Order.
