The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

### FINDINGS OF FACT

- 1. Joseph E. Braun, R.N. (Respondent), (Year of Birth 1979) is licensed in the state of Wisconsin as a registered nurse, having license number 134414-30, first issued on March 10, 2000 and current through February 28, 2022. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is located in West Allis, Wisconsin 53227.
- 2. At all times relevant to this proceeding, Respondent was employed as a registered nurse at a facility (Facility), located in Milwaukee, Wisconsin.
- 3. On December 24, 2019, Respondent assisted another R.N. with an ordered "brief manual hold" on a patient to facilitate administration of intramuscular medications. The patient

had an active "hands on" order due to being uncooperative and combative. Other than gloves, Respondent did not wear a spit mask or equipment to prevent injury to his hands or face.

- 4. During the hold, Respondent placed a sock over the patient's mouth. The patient said, "Don't put that sock in my mouth." One of the psych technicians told Respondent to stop and Respondent removed the sock.
- 5. Respondent told the psych technician that moving his hand with the sock away from the patient's mouth could have resulted in getting bit or spat upon.
- 6. During the Facility's investigation, Respondent stated the patient spit as the patient spoke. No other staff present witnessed the patient spitting or biting anyone.
  - 7. Following the Facility's investigation, the Facility found the following violations:
    - a. Respondent failed to implement the Facility's nursing process by not assessing or developing a plan to provide adequate personal protection during the brief hold.
    - b. Respondent completed the Vistelar Restraint Performance Evaluation in 2018 which discusses safety for the patient and staff. This training revolves around treating people with dignity and respect, which Respondent did not follow.
    - c. Respondent violated the Facility's Personal Protective Equipment policy by not wearing appropriate protective equipment.
    - d. Respondent violated the American Nurses Association Code of Ethics by failing to treat the patient with dignity and respect when placing a sock by or in the patient's mouth.
- 8. Respondent denies engaging in wrongdoing of any kind and denies the allegations described herein.
- 9. Notwithstanding Respondent's denials, in order to resolve this matter in the most expeditious manner, Respondent consents to the entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

- 1. The Wisconsin Board of Nursing has jurisdiction to act in this matter pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondent departed from or failed to conform to the minimal standards of acceptable nursing practice in a way that created an unnecessary risk to a patient's health or safety within the meaning of Wis. Admin. Code § N 7.03(6)(c).

- 3. By the conduct described in the Findings of Fact, Respondent abused a patient by a single act of force, violence, harassment, deprivation, neglect, or mental pressure which reasonably could cause physical pain, injury, mental anguish, or fear within the meaning of Wis. Admin. Code § N 7.03(4)(c).
- 4. As a result of the above conduct, Respondent is subject to discipline pursuant to Wis. Stat. § 441.07(1g)(b) and (d), and Wis. Admin. Code § N 7.03.

#### ORDER

- 1. The attached Stipulation is accepted.
- 2. Respondent is REPRIMANDED.
- 3. The registered nurse license issued to Respondent (license number 134414-30) and his privilege to practice in Wisconsin pursuant to the Enhanced Nurse Licensure Compact (Compact), are LIMITED as follows:
  - a. Within ninety (90) days of the date of this Order, Respondent shall at his own expense, successfully complete three (3) hours of education on the topic of ethics and professionalism in nursing and three (3) hours on the topic of scope of practice and execution of medication orders offered by a provider pre-approved by the Board's monitoring liaison, including taking and passing any exam offered for the courses.
  - b. Respondent shall submit proof of successful completion of the education in the form of verification from the institution providing the education to the Department Monitor at the address stated below. None of the education completed pursuant to this requirement may be used to satisfy any continuing education requirements that have been or may be instituted by the Board or Department, and also may not be used in future attempts to upgrade a credential in Wisconsin.
  - c. This limitation shall be removed from Respondent's license after satisfying the Board or its designee that Respondent has successfully completed all of the ordered education.
- 4. Pursuant to the Compact, Respondent may not practice in another Compact State, other than Wisconsin, while their license is encumbered by any term or restriction of this Order.
- 5. Within 120 days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$560.00.
- 6. Request for approval of courses, proof of successful course completion and payment of costs (made payable to the Wisconsin Department of Safety and Professional Services) shall be sent by Respondent to the Department Monitor at the address below:

- 7. In the event Respondent violates any term of this Order, Respondent's license (134414-30), or Respondent's right to renew his license, may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of the Order. The Board may, in addition and/or in the alternative refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.
  - 8. This Order is effective on the date of its signing.

Respondent Joseph E. Braun, R.N., and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

- 1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.
- 2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:
  - the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
  - the right to confront and cross-examine the witnesses against Respondent;
  - the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
  - the right to testify on Respondent's own behalf;
  - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
  - the right to petition for rehearing; and
  - all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
- 3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.
- 4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Board of Nursing (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.
- 5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division

of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

- 6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.
- 7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.
- 8. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
