The parties in this matter agree to the terms and conditions of the attached Stipulation as the resolution of this renewal application. The Wisconsin Department of Safety and Professional Services (Department) adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

- 1. Applicant Demeteria Chaney filed an application to renew her Private Security Person permit (#51206 -108) on or about August 31, 2020.
- 2. Information received in the application process establishes that Applicant has the following conviction:
 - a. On or about October 15, 2019 Assault and Battery, a misdemeanor conviction.
 - 3. The facts and circumstances of this conviction include but are not limited to the following:
 - a. On June 18, 2019, Applicant and her son went to the home of Applicant's daughter ("DC") and Applicant's daughter's boyfriend ("RDP"). An argument ensued and DC grabbed Applicant and attempted to make her leave the residence. RDP then approached, and Applicant grabbed him by the neck with both hands.

RDP told officers that Applicant had scratched his neck, and a superficial scratch mark was observed.

- b. In a personal statement submitted to the Department, Applicant indicated that prior to the offense, her grandchildren informed her they were being abused by RDP, and she called Child Protective Services out of concern for her grandchildren.
- 4. Department records indicate that Applicant did not report the above conviction to the Department within 48 hours as required under Wis. Admin. Code § SPS 35.01(2).
- 5. In resolution of this matter, Applicant consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Department has jurisdiction over this matter, pursuant to Wis. Stat. §§ 440.08(4) and 440.26, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. Pursuant to Wis. Stat. §§ 440.26(5m)(am) and 440.26(6)(a)(1) and Wis. Admin. Code § SPS 35.01(2), the Department may refuse to issue a Private Security Person permit, or may revoke, suspend or limit the permit of a person who has been convicted of a misdemeanor or found to have violated any state or local law that is punishable by a forfeiture, subject to ss. 111.321, 111.322, and 111.335. Under Wis. Stat. § 111.335(3)(a)1, it is not employment discrimination because of conviction record to refuse to license, or to bar or terminate from licensing, any individual who has been convicted of any misdemeanor or other offense the circumstances of which substantially relate to the circumstances of the particular licensed activity.
- 3. Pursuant to Wis. Stat. § 440.26(6)(a)(4) and Wis. Admin. Code § SPS 31.05(1)(e), the Department may deny an application, or may revoke, suspend, or limit the private security permit of a person who has violated a Department rule or whose conduct is a ground for discipline under Wis. Admin. Code § SPS 35.01. Wis. Admin. Code § SPS 35.01(2) provides that a Private Security Person who has been convicted of a felony, misdemeanor, or ordinance violation shall send to the Department, within 48 hours after the judgment finding the person committed the violation, a copy of the complaint or other information which describes the nature of the offense and the judgment.
- 4. The facts and circumstances of Applicant's conviction referenced above substantially relate to the practice of a Private Security Person. A substantial relationship occurs where "the tendencies and inclinations to behave a certain way in a particular context are likely to reappear later in a related context, based on the traits revealed." County of Milwaukee v. Labor & Indus. Review Comm'n, 139 Wis. 2d 805,824 (1987). The crux of the inquiry is the circumstances which foster criminal activity, e.g. the opportunity for criminal behavior, the reaction to responsibility, or the character traits of the person. Id.
- 5. Private Security Persons are responsible for upholding rules and protecting the security of private property and persons. Private Security Persons are also likely to encounter volatile or stressful situations and are responsible for deescalating rather than escalating those situations. Here, Applicant's conduct would reasonably cause security concerns and reflected Applicant

6. As a result of the conclusions stated above, Applicant's Private Security Person credential renewal application is subject to denial, pursuant Wis. Stat. §§ 440.08(4), 440.26(5m)(am) and 440.26(6)(a)(1) & (4) and Wis. Admin. Code § SPS 35.01(2).

ORDER

- 1. The attached Stipulation is accepted.
- 2. Applicant Demeteria Chancy's Private Security Person permit (#51206-108) is hereby LIMITED and subject to the following limitations, terms, and conditions from the date of this Order.
 - A. For a period of two (2) years from the date of this Order.

i. Practice Limitations

- 1. Applicant shall show a copy of this Order to her current and any future employer(s). Applicant shall provide the Department of Safety and Professional Services Monitor ("Department Monitor") with written acknowledgement from each employer that a copy of this Order has been received. Such acknowledgement shall be provided to the Department Monitor within fourteen (14) days of beginning new employment and/or within fourteen (14) days of the date of this Order
- 2. Applicant shall commit no new violations of law and shall report all law enforcement contacts leading to arrest, charge or conviction, including DWI/OWI and municipal ordinance violations, to the Department Monitor within forty-eight (48) hours of any such event, including any convictions resulting from pending charges.

ii. Reporting Requirements

1. Applicant shall arrange for written reports from her Private Security Person supervisor(s) to be provided to the Department Monitor on a quarterly basis, beginning ninety (90) days from the date of this Order. These reports shall describe the circumstances of Applicant's employment, assess work performance and verify that she is in compliance with the laws governing the practice of a Private Security Person and the terms of this Order.

2. Applicant is responsible for compliance with all of the terms and conditions of this Order, including the timely submission of reports by others. Applicant shall promptly notify the Department Monitor of any suspected violations of any of the terms and conditions of this Order by Applicant.

Department Monitor

1. The Department Monitor is the individual designated by the Department as its agent to coordinate compliance with the terms of this Order. Any requests, petitions, reports or other information required by this Order shall be mailed, faxed or delivered to:

B. Petitions for Modification

i. Applicant may petition the Department for full, unrestricted licensure upon demonstration of continuous, successful practice in compliance with the terms of the Order for at least one (1) year. Applicant's petition must include her history of employment from the effective date of this Order that states the dates and names of any employer, such employment in total equaling one (1) year of practice. Any such petition shall be accompanied by a written recommendation from Applicant's current employer that includes, among other things, the dates of employment and scope of responsibility during such employment. A denial of such a petition for modification shall not be deemed a denial of license under Wis. Stat. §§ 227.01(3), or 227.42, or Wis. Admin. Code ch. SPS 1, and shall not be subject to any right to further hearing or appeal.

C. Costs

i. Applicant shall be responsible for all costs and expenses associated with compliance with the terms of this Order.

D. Suspension

To: 16082662264

i. If Applicant violates any term of this Order, Applicant's credential may, in the discretion of the Department or its designee, be SUSPENDED, without further notice or hearing, until Applicant has complied with the terms of the Order. The Department may, in addition and/or in the alternative, refer any violation of this Order to the Department's Division of Legal Services and Compliance for further investigation and action.

STIPULATION

ORDER 0007396

Applicant Demeteria Chaney and the Wisconsin Department of Safety and Professional Services stipulate as follows:

- This Stipulation is entered into as a result of a review of Applicant's renewal application for a Private Security Person permit (#51206-108). Applicant consents to the issuance of the Order attached as resolution of that application.
- 2. Information received by the Department reflects a basis for denial of Applicant's renewal application.
- 3. Based upon the information of record herein, the Department agrees to issue and Applicant agrees to accept an Order Granting a Limited License for renewal of a Private Security Person credential, subject to the terms and conditions set forth in the attached Order adopting the Stipulation.
- 4. Applicant understands that by signing this Stipulation, Applicant voluntarily and knowingly waives the following rights:
 - the right to a hearing on the conduct allegations against Applicant, related to the denial of the renewal application, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
 - the right to confront and cross-examine the witnesses against Applicant;
 - the right to call witnesses on Applicant's behalf and to compel their attendance by subpoena;
 - the right to testify on Applicant's own behalf,
 - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
 - the right to petition for rehearing; and
 - all other applicable rights afforded to Applicant under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

- 5. Applicant is aware of Applicant's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.
- 6. Applicant agrees to the adoption of the attached Order Granting Limited License by the Department. The parties to the Stipulation consent to the entry of the attached Order Granting Limited License without further notice, pleading, appearance, or consent of the parties. Applicant waives all rights to any appeal of the Department's order, if adopted in the form as attached.

7. Applicant is informed that should the Department adopt this Stipulation, the Department's Order Granting Limited License is a public record and will be published in accordance with standard Department procedure.
