On June 10, 2021, the Wisconsin Board of Nursing (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s professional nursing license with certain terms and conditions.

On October 14, 2021, the Board reviewed Respondent’s fit to practice evaluation. The Board granted the return of her license to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:
