Nature of Complaint Summary: Failure to submit building plans

Object Type: Complaint (21 COM 50)

INVESTIGATION NOTES: An original Notice of Violations and Orders was entered against this site on June 7, 2018. No steps toward compliance were taken. This updated Notice of Violations and Orders shall replace the original Order as the Department became aware of new ownership. Property owners shall immediately begin working toward compliance. Failure to comply with this Order may lead to forfeitures or Stop Use Orders as allowed by Wisconsin Administrative Code SPS Chapter 303.

NOTE: Due to the uncertainty caused by COVID-19 the Department will extend compliance dates so long as work is being made on gaining compliance with orders or if the site is not being used due to restrictions.

The following violations were revealed at 4530 N Branch Street:

1. Violation: Building plans were not submitted for review and conditional approval for the newly constructed rescue squad alteration by the Department prior to commencing construction on this project as required.

# Wis. Admin. Code § SPS 361.03 Application:

- (1) Standards.
- (a) The design and construction of public buildings and places of employment shall comply with s. SPS 361.05, except as otherwise provided in chs. SPS 361 to 366.
- (b) The codes and standards that are referenced in this chapter, and any additional codes and standards which are subsequently referenced in those codes and standards, shall apply to the prescribed extent of each such reference, except as modified by this chapter.
- (c) The requirements in IBC Appendix C may be applied to certain agricultural buildings, as specified in s. SPS 362.3600 (2), in lieu of corresponding, otherwise applicable requirements of chs. SPS 361 to 366.

Wis. Admin. Code § SPS 361.30 Plan review and approval. (1) TYPES OF BUILDINGS. (a) Except as provided in par. (b), Table 361.30–1, and sub. (4), the construction of, the alteration of, or the addition to a public building or a place of employment may not commence unless plans for the project have been submitted to and approved by the department or its authorized representative in accordance with s. SPS 361.31.

Required Action: Submit four sets of building plans (or one planset and three additional index sheets), with one set of calculations and specifications, a completed SBD-118 form, a copy of orders as issued by a Dept. representative from the field, and double fees to this Department for review and approval. If the building is over 50,000 cubic feet in total volume, all plans, calculations and specifications shall be properly stamped, signed and dated by a WI-registered architect or engineer.

2. Violation: HVAC plans not submitted.

SPS 361.30(3) - HVAC plans and appropriate calculations with fees were not submitted for review and conditional approval by the Department prior to installation. The submitted HVAC plans shall match the approved building plans. Note: as per SPS 302.10 installation of HVAC without approved plans will result in double plan review fees at the time of plan submission.

Required Action: Submit four (4) sets of plans, with one (1) set of calculations all of which are to be properly stamped, signed and dated, a completed SBD-118 form, a copy of orders as issued by a Dept. representative from the field.

You are hereby ordered to have the installation corrected to conform to the indicated provisions of the Wisconsin Administrative Code and/or Wisconsin Statutes. This installation shall be corrected by the compliance date noted, and upon correction of violations I must be notified. If you fail to comply, this order is enforceable in circuit court pursuant to Wis. Stat. 101.02(13), Stats., with forfeitures ranging from \$10 to \$100 per day for each violation.

Wis. Admin. Code § SPS 303.03 Permits any person affected by a rule of the department to petition for a variance of the rule. The petition needs to establish equivalency to the rule, be provided on the form from the department and be submitted with accompanying fee and municipal recommendation.

Wis. Stat. § 101.02(6) Any employer or other person interested either because of ownership in or occupation of any property affected by any such order, or otherwise, may petition for a hearing on the reasonableness of any order of the department in the manner provided in this subchapter. All requests must be received within 30 days of the date of this Order and shall set out specifically and in full detail the order upon which a hearing is desired and every reason why such order is unreasonable, and every issue to be considered by the department on the hearing. The petitioner shall be deemed to have finally waived all objections to any irregularities and illegalities in the order upon which a hearing is sought other than those set forth in the petition.

If the building is over 50,000 cubic feet in total volume, all plans, calculations and specifications shall be properly stamped, signed and dated by a WI-registered architect or engineer.

Plans were not approved by the department for the newly constructed rescue squad alteration.

SPS 361.30(3) - HVAC plans and appropriate calculations with fees were not submitted for review and conditional approval by the Department prior to installation.
