On June 16, 2021, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's license to practice medicine and surgery. Respondent was required to complete four (4) hours of education in proper opioid prescribing and monitoring and four (4) of education on diagnosis and treatment of back pain pursuant to the terms of the Order.
