On June 16, 2021, the Wisconsin Medical Examining Board (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s license to practice medicine and surgery. Respondent was required to complete four (4) hours of education in proper opioid prescribing and monitoring and four (4) of education on diagnosis and treatment of back pain pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:

ORDER

1. Respondent’s license to practice medicine and surgery (license number 39913-20) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credential are removed.
3. This order is effective the date of its signing.
