You are hereby notified that you are subject to a forfeiture of \$1,000.00 in accordance with Wis. Admin. Code § SPS 305.125 for engaging in plumbing installations without holding an appropriate master plumber license in violation of Wis. Stat. § 145.06. This forfeiture must be paid within 30 days of the date of mailing of this Notice, or a 12% interest penalty will be assessed and/or enforcement action may be taken against you.

This forfeiture consists of a \$1,000.00 forfeiture as allowed by Wis. Admin. Code § SPS 305.125 for engaging in plumbing without a license in violation of Wis. Stat. § 145.06 and Wis. Admin. Code § SPS 305.90. You shall be unable to obtain a license or credential from the Department of Safety and Professional Services until this forfeiture is paid.

The forfeiture of \$1,000.00 shall be made out to the "Department of Safety and Professional Services." Include in the memo line "20 COM 47" and send to the following address:

You have the right to request a review of the assessment of forfeiture by sending a request addressed to Division Administrator, Division of Industry Services, P.O. Box 7302, Madison, WI 53707-7302. Any review of the assessment of forfeiture will be held in accordance with the requirements set forth in Wis. Admin. Code § SPS 305.125. Such request for review shall set out

specifically and in full detail every reason why this order is unreasonable, and every issue to be considered by the Department in the review.

You are receiving this forfeiture because you engaged in plumbing without a license. An investigation by the Department found that you engaged in plumbing at 8325 Side Road, Forestville, Wisconsin when you prepared the mound system and set parts in the mound system including plumbing. According to Wis. Admin. Code § SPS 305.125(1)(b), the first violation of plumbing without a license subjects you to a forfeiture of \$1,000.

For these reasons a forfeiture of \$1,000.00 is assessed in accordance with Wis. Admin. Code § SPS 305.125.
