On July 21, 2021, the Wisconsin Medical Examining Board (“Board”) issued a Final Decision and Order (“Order”) suspending Respondent’s certificate to practice as a respiratory care practitioner for an indefinite period. Respondent may petition for a stay of suspension upon providing proof, which is determined by the Board or its designee to be sufficient, that Respondent is in compliance with the provisions of Sections C and D of the Order, for a period of at least thirty (30) consecutive days.

Respondent’s petition for an initial stay of suspension has been reviewed pursuant to the Order. Based upon the information of record, which demonstrates that Respondent qualifies for a stay of suspension at this time, the following is entered:

ORDER

1. The suspension of Respondent’s certificate to practice as a respiratory care practitioner (certificate number 3257-28) is hereby STAYED.
2. The stay is continuous, contingent upon Respondent’s compliance with the terms and conditions of the Order.
3. This order is effective the date of its signing.
