On July 21, 2021, the Wisconsin Medical Examining Board (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s license to practice medicine and surgery. Respondent was required to complete the Medical Ethics, Boundaries, and Professionalism course offered by Case Western Reserve University School of Medicine, or an equivalent course that has been pre-approved by the Board or its designee.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:

1. Respondent’s license to practice medicine and surgery (license number 53307-20) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credential are removed.
