
On August 12, 2021, the Board of Nursing (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s professional nursing license. Respondent was required to complete three (3) hours of education on the topic of ethics and the Wisconsin Nurse Practice Act course provided/offered by the National Council of State Boards of Nursing (NCSBN) pursuant to the terms of the Order.

Respondent has submitted proof that she successfully completed the required education and as a result the following is entered:

1. Respondent’s professional nursing license (license number 246305-30) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credential are removed.
