On August 12, 2021, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) requiring Respondent to complete three (3) hours of education in “ethics” and three (3) hours of education in “documentation” within ninety (90) days. Respondent is also required to pay \$925.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. The suspension is terminated and Respondent’s professional nursing license (#188084-30) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credential are removed.
3. This order is effective the date of its signing.
