You are hereby notified that you are subject to a forfeiture of **\$1,000.00** in accordance with Wis. Admin. Code § SPS 305.125 for engaging in plumbing without possessing a proper plumbing credential. This forfeiture must be paid within 30 days of the date of mailing of this Notice, or a 12% interest penalty will be assessed and/or enforcement action may be taken against you. Further, you shall not be allowed to obtain a credential from the Department of Safety and Professional Services until this forfeiture is paid.

The forfeiture of **\$1,000.00** shall be made out to the "Department of Safety and Professional Services." Include in the memo line "20 UNL 82" and send to the following address:


You have the right to request a review of the assessment of forfeiture by sending a request addressed to Division Administrator, Division of Industry Services, P.O. Box 7302, Madison, WI 53707-7302. Any review of the assessment of forfeiture will be held in accordance with the requirements set forth in Wis. Admin. Code § SPS 305.125. Such request for review shall set out specifically and in full detail every reason why this order is unreasonable, and every issue to be considered by the Department in the review.

You are receiving this forfeiture because a department investigation found that you engaged in plumbing without a license. Specifically, the investigation found a preponderance of evidence that you performed plumbing at 521 N. 25<sup>th</sup> Street, Milwaukee, WI. You were hired to remodel a home. Your work logs state the following:

- February 13: Plumbing for the washer.
- February 14: Plumbing day. Water and sewer lines installation.
- February 17: Completed installation of water lines.
- February 21: Sewer lines in basement complete including toilet flange.
- February 22: Toilet install.

Based on these work logs, your response to the Department, and a review of the Codes and Statutes there is a preponderance of evidence that you engaged in unlicensed plumbing. Wisconsin code states that the Department may issue a forfeiture against an unlicensed individual if it is found that the individual installs plumbing when a master plumber is not in charge of the plumbing installation. For these reasons a forfeiture of \$1,000.00 is assessed in accordance with Wis. Admin. Code § SPS 305.125.

NOTICE OF FORFEITURE

Re: UNLICENSED ELECTRICAL WORK

You are hereby notified that you are subject to a forfeiture of **\$250.00** in accordance with Wis. Stat. § 101.88(3) because you engaged in electrical work without possessing the necessary credential in violation of Wis. Stat. § 101.862(2). This forfeiture must be paid within 30 days of the date of mailing of this Notice, or a 12% interest penalty will be assessed and/or enforcement action may be taken against you. In addition, you shall not be able to obtain a credential from the Department of Safety and Professional Services until this forfeiture is paid.

The forfeiture of **\$250.00** shall be made out to the "Department of Safety and Professional Services." Include in the memo line "20 UNL 82" and send to the following address:

You are receiving this forfeiture because a Department investigation found you performed electrical work at 521 N. 25<sup>th</sup> Street, Milwaukee, WI without possessing any electrical license. A license is required in the State of Wisconsin to perform most electrical work. An investigation by the Department found a preponderance of evidence that you engaged in electrical work. The Department reviewed an invoice that showed electrical wiring/equipment purchased by you for the project and work logs indicating that you removed electrical wiring.

You have the right to request a hearing on this matter by sending a request for hearing to the Department of Safety and Professional Services, Chief Legal Counsel, P.O. Box 7190, Madison,

Wisconsin 53707-7190, which must be received by the Department no later than 30 days from the date of mailing of this Notice. Any review will be held in accordance with the requirements set forth in Wis. Stat. § 101.02(6). Such request for review shall set out specifically and in full detail every reason why this order is unreasonable, and every issue to be considered by the Department in the review

For engaging in electrical work without the proper credential the forfeiture of \$250.00 is assessed in accordance with Wis. Stat. § 101.88(3).
