On September 15, 2021, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's medicine and surgery license. Respondent was required to complete three (3) hours of education in appropriate documentation, oversight, and performance of Botox procedures and provide proof of certification to perform Botox, Juvaderm, Vbeam and Nanofat services pursuant to the terms of the Order.

Respondent has submitted proof that she successfully completed the required education and as a result the following is entered:

ORDER

1. Respondent's medicine and surgery license (license number 27546-20) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
