On October 12, 2021, the Wisconsin Professional Counselor Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board ("Section") issued a Final Decision and Order ("Order") limiting Respondent's licenses to practice professional counseling and professional counseling-in-training. Respondent was required to complete four (4) hours of education in mandated reporting pursuant to the terms of the Order.

Respondent has submitted proof that she successfully completed the required education and as a result the following is entered:

1. Respondent's licenses to practice professional counseling and professional counseling-in-training license (license numbers 8154-125 and 4154-226) are returned to full, unrestricted status.
