The parties agree to the terms and conditions of the attached Stipulation as an Interim Order in this matter, subject to the approval of the Medical Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusion of Law, and Order.

FINDINGS OF FACT

1. Respondent Jonathan J. Brodie, M.D., (Year of Birth 1962) is licensed in the state of Wisconsin to practice medicine and surgery, having license number 30363-20, first issued on July 1, 1989, with registration current through October 31, 2021. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is in Delafield, Wisconsin 53018-3866.

2. On June 4, 2021, Respondent self-reported a deferred judgment entered in South Dakota for possession of a controlled substance. The Division of Legal Services and Compliance, on behalf of the Board, opened case number 21 MED 233 to investigate.

3. On September 26, 2019, Respondent was charged with vehicular battery, possession of cocaine, possession of methamphetamine, possession of psilocybin mushrooms, and driving under the influence, in Pennington County Circuit Court, Seventh Judicial Circuit, Case No. 51CRI-19-4139 in South Dakota. The date of the incident underlying the charges was August 9, 2019. On May 3, 2021, Respondent pleaded guilty to possession of cocaine (a class 5 felony) and entered into a deferred judgment agreement.

4. On March 18, 2021, Respondent was charged in Waukesha County Circuit Court Case No. 2021CF000444 with one count of Possession of Methamphetamine, a class I felony, in violation of Wis. Stat. § 961.41(3g)(g); one count of Possession of THC, an unclassified misdemeanor, in violation of Wis. Stat. § 961.41(3g)(e); and one count of Possess Drug Paraphernalia, an unclassified misdemeanor, in violation of Wis. Stat. § 961.573(1). The date of the incident underlying the charges was March 17, 2021.

5. Respondent pleaded not guilty to the criminal charges in Waukesha County and that case is pending.

6. The Board has not made a determination as to the validity of the allegations underlying the charges in South Dakota or Wisconsin.

7. Respondent's consent to the entry of this Interim Order does not constitute an admission of guilt of the allegations referenced in paragraphs 3 and 4 above, or of any act of professional misconduct.

8. Respondent has voluntarily agreed not to engage in the practice of medicine and surgery in the state of Wisconsin pending the final resolution of the above-referenced criminal charges in Wisconsin and this disciplinary matter.

CONCLUSION OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 448.02(3), and has authority to enter into this stipulation for an Interim Order pursuant to Wis. Stat. § 227.44(5).

ORDER

1. The Stipulation of the parties is accepted.

2. Respondent's license and registration to practice medicine and surgery in the state of Wisconsin (license no. 30363-20) is SUSPENDED during the pendency of this disciplinary matter.

3. The suspension shall remain in effect until the Board issues a Final Decision and Order in this disciplinary matter.

4. This Order is effective on the date of its signing.

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance.

2. Respondent is aware of his right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation. Respondent is represented by Attorney Stacie Rosenzweig.

3. Respondent neither admits nor denies the allegations in this matter, but agrees to the adoption of the attached Interim Order by the Medical Examining Board (Board). The parties to the Stipulation consent to the entry of the attached Interim Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.

4. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall be returned to the Division of Legal Services and Compliance for further proceedings. In the event that this Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner.

5. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board assigned as a case advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent or Respondent's attorney, if any, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with the Board's deliberations on the Stipulation. Additionally, any such case advisor may vote on whether the Board should accept this Stipulation and issue the attached Interim Order.

6. Respondent is informed that should the Board adopt this Stipulation and Interim Order, the Board's Interim Order is a public record and will be published in accordance with standard Department procedure.

The Division of Legal Services and Comphance joins Respondent in **mending that the Board adopt this Stipulation and assue the attached Interim Order**
