NOTICE OF FORFEITURE

Re: Unlicensed Electrical Work -- 201 Front Street, Cassville, Wisconsin

You are hereby notified that you are subject to a forfeiture of **\$500.00** in accordance with Wis. Stat. § 101.88 because you engaged in electrical wiring work without possessing a proper credential in violation of Wis. Stat. § 101.862. This forfeiture must be paid within 30 days of the date of mailing of this Notice, or a 12% interest penalty will be assessed and/or enforcement action may be taken against you.

The forfeiture of **\$500.00** shall be made out to the "Department of Safety and Professional Services." Include in the memo line "19 UNL 69" and send to the following address:

You are receiving this forfeiture because you performed electrical wiring work at 201 Front Street, Cassville, Wisconsin without possessing a valid electrical license. An investigation was opened and you responded to the Department admitting that you engaged in electrical wiring work at this site. You claimed that the Department's inspector told you that you were within your rights to do that work. The investigation found that not to be true. Both the Department inspector and the local inspector determined that the work done required a valid electrician's license. A review of the Department's credentialing records shows that you do not possess an electrical license. This is a violation of Wis. Stat. § 101.862 and Wis. Admin. Code § SPS 305.40.

Violating rules and statutes adopted by the Department carries with it a forfeiture of no less than \$25.00 nor more than \$500 for each violation as allowed by Wis. Stat. § 101.88.

For these reasons the forfeiture of \$500.00 is assessed in accordance with Wis. Stat. § 101.88.
