NOTICE OF FORFEITURE

Re: UNLICENSED AND CODE DEFICIENT ELECTRICAL WORK

You are hereby notified that you are subject to a forfeiture of **\$8,000.00** in accordance with Wis. Stat. § 101.88(3) because you engaged in electrical work without possessing the necessary credential in violation of Wis. Stat. § 101.862(2) and your electrical work was code deficient in violation of the rules created under Wis. Stat. § 101.82(1). This forfeiture must be paid within 30 days of the date of mailing of this Notice, or a 12% interest penalty will be assessed and/or enforcement action may be taken against you. In addition, you shall not be able to obtain a electrical credential from the Department of Safety and Professional Services until this forfeiture is paid as allowed by Wis. Stat. § 440.21(2).

The forfeiture of **\$8,000.00** shall be made out to the "Department of Safety and Professional Services." Include in the memo line "21 COM 18" and send to the following address:

You are receiving this forfeiture because a Department investigation found you performed electrical work at 9388 Alpine Road, Fremont Wisconsin without possessing any electrical license. A license is required in the State of Wisconsin to perform most electrical work including the work you performed. An investigation by the Department found by a preponderance of the

evidence that you engaged in electrical work. In addition, the Department conducted an inspection of the work done and noted fifteen (15) electrical code violations adopted via Wis. Admin. Code § SPS 316.007(1)(a):

1. **NEC 690.43** No equipment grounding/bonding conductor installed or connected to the remote PV array.
2. **NEC 690.31(A)** PV circuit conductors at the array are not guarded or installed in a raceway or MC cable.
3. **NEC 110.12(A)** Electrical enclosures on and in the house have unused openings that are not closed.
4. **NEC 312.5(C)** Cables entering electrical enclosures on and in the house are not secured to the enclosures.
5. **NEC 338.10(B)(4), NEC 334.30** Cables on and in the house are not properly secured and supported.
6. **NEC 338.10(B)(4), 334.15(A)** Cables on and in the house do not closely follow the building surface.
7. **NEC 352.30** PVC conduit from inverter to PV interface not properly secured and supported.
8. **NEC 200.7(A)** Cable from PV interface to panel is using the black conductor with a white stripe as an ungrounded conductor.
9. **NEC 250.110** No equipment grounding conductor installed from the service disconnect to the PV interface.
10. **NEC 250.110** No equipment grounding conductor installed from the PV interface to the panel.
11. **NEC 250.24(A)(5)** Neutrals and equipment grounds not separated in panel.
12. **NEC 705.12(B)(2)(1)(a)** Feeder from service disconnect to PV interface not sized properly.
13. **NEC 690.31(B)(1)&(2)** PV system circuits not identified.
14. **NEC 690.54** Interactive point of interconnection is not marked.
15. **NEC 690.56(C)(1)** Rapid shutdown markings are not applied.

You have the right to request a hearing on this matter by sending a request for hearing to the Department of Safety and Professional Services, Chief Legal Counsel, P.O. Box 7190, Madison, Wisconsin 53707-7190, which must be received by the Department no later than 30 days from the date of mailing of this Notice. Any review will be held in accordance with the requirements set forth in Wis. Stat. § 101.02(6). Such request for review shall set out specifically and in full detail every reason why this order is unreasonable, and every issue to be considered by the Department in the review

The Department is authorized to enter forfeitures up to \$500 for each violation of Wisconsin electrical statute or code. For engaging in electrical work without the proper credential and for

performing code deficient work the forfeiture of \$8,000.00 is assessed in accordance with Wis. Stat. § 101.88(3).
