You are hereby notified that you are subject to a forfeiture of \$800.00 in accordance with Wis. Stat. § 101.88(3) because you engaged in the business of electrical work without possessing an electrical contractor license in violation of Wis. Stat. § 101.862(1). This forfeiture must be paid within 30 days of the date of mailing of this Notice or enforcement action may be taken against you. In addition, you shall not be able to obtain a credential with the Department until this forfeiture is paid.

The forfeiture of \$800.00 shall be made out to the "Wisconsin Department of Safety and Professional Services." Include in the memo line "21 COM 84" and send to the following address:

You are receiving this forfeiture because a Department investigation found your company performed electrical work at 2446 28th Street, Rice Lake, Wisconsin without possessing any electrical license. A license is required in the State of Wisconsin to perform most electrical work. An investigation by the Department found by a preponderance of the evidence that you engaged in electrical work. The Department spoke with you and you admitted your company performed the electrical work.

The basis of the forfeiture stems from the days you were at the site performing electrical work. The project began on February 22, 2021, and ended on March 12, 2021. You stated that your company performed 20 hours of electrical work. The Department utilized discretion and found that a forfeiture for \$800.00 was appropriate. Wisconsin allows for up to \$500/day for a violation.

Upon the payment of the forfeiture if you wish to continue performing electrical work you shall immediately obtain the appropriate credential. You shall cease and desist from any electrical work until you possess the proper credential. Failure to do so can lead to future disciplinary actions.

You have the right to request a hearing on this matter by sending a request for hearing to the Department of Safety and Professional Services, Chief Legal Counsel, P.O. Box 7190, Madison, Wisconsin 53707-7190, which must be received by the Department no later than 30 days from the date of mailing of this Notice. Any review will be held in accordance with the requirements set forth in Wis. Stat. § 101.02(6). Such request for review shall set out specifically and in full detail every reason why this order is unreasonable, and every issue to be considered by the Department in the review.

For engaging in electrical work without the proper credential and for operating a business without the proper credential the forfeiture of \$800.00 is assessed in accordance with Wis. Stat. § 101.88(3).
