The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Medical Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

- 1. Respondent Adil Humayun, M.D., (Year of Birth 1988) is licensed in the state of Wisconsin to practice medicine and surgery, having license number 72294-20, first issued on November 25, 2019, with registration current through October 31, 2023. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is in Temple, Texas 76502.
- 2. At all times relevant to this proceeding, Respondent was a senior resident practicing medicine at a medical center's pediatric clinic in Marshfield, Wisconsin (Clinic).
- 3. On April 8, 2021, Patient A, a four-year-old female, presented to Respondent at the Clinic with her mother, who reported Patient A had experienced nausea, vomiting, decreased

appetite, and intermittent fever since April 5, 2021. The triage nurse charted "when mom rubs on her stomach she says 'ouch."

- 4. Patient A entered the examination room in a wheelchair. Respondent asked Patient A if she felt comfortable getting out of the wheelchair so he could examine her, but she said she was uncomfortable standing or moving because it caused her to be nauseous and, in fact, began to exhibit dry heaving.
- 5. Respondent examined Patient A in the wheelchair and did not conduct an examination of Patient A's abdomen on the examination table. Respondent's examination demonstrated diffusely distributed tenderness throughout the abdomen with no specific localization and mild voluntary guarding throughout. Respondent charted "[n]o specific tenderness at McBurney's point, or Murphy's sign. No masses, rigidity, or organomegaly."
- 6. Respondent's assessment was viral gastritis, charting that Patient A had reassuring signs of hydration and tolerated clear fluids that morning. Respondent maintains that although appendicitis was on list of differential diagnoses, Patient A's specific complaints and symptomology as presented led him to an assessment of gastritis.
- 7. Respondent prescribed Zofran and gave instructions to provide small volumes of clear liquids every 15-30 minutes as tolerated, introduce bland foods, and return to the Clinic if Patient A had poor tolerance of fluids, continued vomiting, lethargy, severe abdominal pain, or fevers unresponsive to antipyretics for three or more days.¹
- 8. On April 10, 2021, Patient A was brought to the emergency department unresponsive. She died at 4:38 p.m. from acute bacterial peritonitis due to a ruptured appendicitis.
- 9. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 448.02(3) and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondent engaged in unprofessional conduct pursuant to Wis. Admin. Code § Med 10.03(2)(b) by departing from or failing to conform to the standard of minimally competent medical practice which created an unacceptable risk of harm to a patient whether or not the act or omission resulted in actual harm to any person.
- 3. As a result of the above conduct, Respondent is subject to discipline pursuant to Wis. Stat. § 448.02(3) and Wis. Admin. Code Ch. Med 10.

¹ Respondent presented his examination findings to his supervising physician who agreed with his assessment and plan.

ORDER

- 1. The attached Stipulation is accepted.
- 2. Respondent is REPRIMANDED.
- 3. Respondent's license to practice medicine and surgery in the state of Wisconsin (license number 72294-20) is LIMITED as follows:
 - a. Within ninety (90) days of the date of this Order, Respondent shall, at his own expense, successfully complete four (4) hours of education on the topic of assessing for an acute abdomen offered by a provider pre-approved by the Board's monitoring liaison, including taking and passing any exam offered for the courses.
 - b. Respondent shall submit proof of successful completion of the education in the form of verification from the institution providing the education to the Department Monitor at the address stated below. None of the education completed pursuant to this requirement may be used to satisfy any continuing education requirements that have been or may be instituted by the Board or Department, and also may not be used in future attempts to upgrade a credential in Wisconsin.
 - c. The Board's monitoring liaison may change the number of credit hours and/or education topics in response to a request from Respondent. The monitoring liaison may consider the topic availability and/or hours of education when determining if a change to the ordered education should occur.
 - d. This limitation shall be removed from Respondent's license after satisfying the Board or its designee that Respondent has successfully completed all the ordered education.
- 4. Within ninety (90) days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$462.00.
- 5. Any requests, petitions, payments of costs (made payable to Department of Safety and Professional Services), and other information required by this Order shall be submitted to:

6. In the event Respondent violates any term of this Order, Respondent's license (number 72294-20), or Respondent's right to renew his license, may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied

with the terms of the Order. The Board may, in addition and/or in the alternative refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.

7. This Order is effective on the date of its signing.

Respondent Adil Humayun, M.D., and the Division of Legal Services and Compliance, Department of Safety and Professional Services, stipulate as follows:

- 1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.
- 2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:
 - the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
 - the right to confront and cross-examine the witnesses against Respondent;
 - the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
 - the right to testify on Respondent's own behalf;
 - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
 - the right to petition for rehearing; and
 - all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
- 3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.
- 4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Medical Examining Board (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.
- 5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division

of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

- 6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.
- 7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.
- 8. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
