On March 13, 2012, the Wisconsin Cemetery Board ("Board") issued a Final Decision and Order ("Order") limiting the cemetery authority license (license no. 95-86) of Respondent Rienzi Cemetery and limiting Respondent Rienzi Cemetery Association's preneed seller license (license no. 101-239) with certain terms and conditions.

On August 9, 2022, the Board considered Respondents' request for the termination of Paragraph 3 (a-c). Based upon the information of record, the Board finds and makes the following:

1. Respondents' request for the termination of Paragraph 3 (a-c) is hereby GRANTED.
2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
