On April 10, 2014, the Wisconsin Board of Nursing (“Board”) issued a Final Decision and Order (“Order”) suspending Respondent’s practical nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On November 10, 2022, the Board considered Respondent’s requests to discontinue AODA Treatment, have access to controlled substances and a reduction in drug and alcohol screens. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent’s requests to discontinue AODA Treatment and to have access to controlled substances is hereby GRANTED.
2. Respondent’s request for a reduction in drug and alcohol screens is hereby DENIED.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
