On July 20, 2015, the Wisconsin Physical Therapy Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's five (5) year right to renew his license to practice physical therapy for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.

On August 10, 2022, the Board considered Respondent's request for the return of full, unrestricted licensure. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's license to practice physical therapy (#9916-24) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are hereby removed.
3. This order is effective the date of its signing.
