On January 27, 2016, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board ("Section") issued a Final Decision and Order ("2016 Order") limiting Respondent's clinical social work license with certain terms and conditions. On February 9, 2018, upon completion of the evaluation required by the 2016 Order, the Section issued an order imposing additional limitations on Respondent's license.
