On January 27, 2016, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board ("Section") issued a Final Decision and Order ("2016 Order") limiting Respondent's clinical social work license with certain terms and conditions. On February 9, 2018, upon completion of the evaluation required by the 2016 Order, the Section issued an order imposing additional limitations on Respondent's license.

On February 11, 2022, the Section considered Respondent's request for termination of treatment reporting requirement. Based upon the information of record, the Section finds and makes the following:

ORDER

1. Respondent's request for termination of treatment reporting requirement is hereby DENIED.
2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
3. This order is effective the date of its signing.
