On August 17, 2016, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counselor, and Social Work Examining Board ("Section") issued a Final Decision and Order ("Order") suspending Respondent's advanced practice social worker certificate for an indefinite period. Respondent has been granted a stay of suspension and her certificate is currently limited with certain terms and conditions.

On October 18, 2022, the Section considered Respondent's request for the return of full, unrestricted licensure. Based upon the information of record, the Section finds and makes the following:

ORDER

1. Respondent's advanced practice social worker certificate (certificate number 129264-121) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are hereby removed.
3. This order is effective the date of its signing.
