On September 15, 2016, the Wisconsin Department of Safety and Professional Services issued a Final Decision and Order ("Order") limiting Respondent's certificate to practice as a substance abuse counselor with certain terms and conditions. Pursuant to the Order, Respondent's certificate may be suspended, without hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Respondent has ceased to participate in the approved drug monitoring program without Department approval and therefore is in violation of the terms of the Order. As a result, the following is entered:

ORDER

1. Respondent's certificate to practice as a substance abuse counselor (#15422-132) is hereby SUSPENDED until further notice.
2. This order is effective the date of its signing.
