On January 19, 2017, the Wisconsin Real Estate Examining Board (“Board”) granted Applicant a limited real estate salesperson license in the state of Wisconsin. Pursuant to the Order Granting Limited Certificate of Registration (“Order”) issued on the same date, Applicant may petition the Board for removal of the limitations upon the completion of at least two (2) years of practice in compliance with all terms and conditions of the Order.

On June 16, 2022, the Board considered Applicant’s request for a full, unrestricted real estate salesperson license. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Applicant’s request for the return of his real estate salespersons license (license number 83339-94) to full, unrestricted status is hereby GRANTED.
2. All limitations and encumbrances upon Applicant’s credential are hereby removed.
