On March 9, 2017, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license (#173007-30) for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On August 11, 2022, the Board considered Respondent's request for Virginia to be the primary monitoring state. Based upon the information of record, the following is entered:
