On March 7, 2018, the Wisconsin Dentistry Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's license to practice dentistry. Respondent was required to successfully complete four (4) hours of remedial education on the topic of the of radiography in pediatric dentistry, four (4) hours of remedial education on the topic of patient health care record keeping, and eight (8) hours of remedial education on the topic of treatment planning. In addition, Respondent was required to successfully complete twelve (12) hours of remedial education on the topic of endodontics, at least six (6) hours of which needed to be hands on. Respondent was required to meet with a professional mentor, at least monthly for at least eighteen (18) months from the date the Board or its designee approved the mentor and to ensure quarterly mentor reports were submitted. Respondent's license to practice dentistry was also permanently limited.

The Board designee considered Respondent's request for termination of the professional mentor requirement. Respondent has submitted proof that he successfully completed the required education. Based upon the information of record, the following is entered:

## <u>ORDER</u>

1. Respondent's request for termination of the professional mentor requirement is GRANTED.

2. The education limitation is removed from Respondent's license to practice dentistry (license number 2328-15).

3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.

4. This order is effective the date of its signing.
